MILDEW: Remove any mildew prior to staining. Mildew is not caused by the stain nor does it represent failure of the stain. Mold and mildew can grow on either treated or untreated wood. Routine cleaning with ABR Deck and Siding Wash can keep the wood surface clean.

EXTRACTIVE BLEEDING: Extractive bleeding is not caused by this product, nor is it a sign of product failure. To remove discoloration use X-180 Weathered Wood Restorer.

ANNUAL CLEANING: This product will not prevent your deck from accumulating dirt, nor is a dirty deck a sign of product failure. Routine maintenance cleaning with ABR Deck and Siding Wash is required to keep up the clean appearance of your deck.

TINTING OR INTER MIXING: Do not tint or intermix.



- When cleaning use a power washer.
- Stain must be able to penetrate wood. Prior coatings must be removed. Use Super Bio Strip or other suitable ABR coatings remover.

APPLICATION

- Before beginning the overall project a test application must be performed to determine proper application and desired effect.
- Shake and stir before and during use.
- If project requires more than one single container blend all containers together.
- When rolling or spraying, back brush immediately to ensure uniformity.
- The color of the finish will vary depending upon the porosity and texture of the woods surface.
- Do not apply if rain is imminently forecasted within 12 hours of final application.
- Apply with roller, brush, pad or professional spray equipment.
- Do not apply if surface temperature is below 40° F or above 90° F.
- Do not thin this product.

DAMP WOOD

- Apply to wood that is DAMP without standing water.
- or broom.
- One coat is recommended
- If a deeper color is desired, apply a based on project test.
- · Remove standing water with a squeegee
- second coat after a minimum of 2 hours,

DRY WOOD

- To avoid premature drying and lap marks never attempt to finish a surface that is hot to the touch or in direct sunlight, (use damp wood application).
- . Apply first coat of stain being careful to spread evenly. Spread excess stain that has puddle on surface with a dry pad or brush.
- If required for a deeper color, apply a second coat after a minimum of 2 hours. depending upon the temperature, humidity and dry time.
