Directions For Use

SHAKE WELL BEFORE USING

AS A HAND CLEANSER: Turn upside down and press top to release cleaning foam. Apply a golf ball size mound of product to palm of dry hand. Massage into hands, both front and back, until no foam is left. Dry hands.

AS A SURFACE CLEANSER: Turn upside down and press top to release cleaning foam. Apply to surface and wipe with a dry paper towel until no foam is left and surface is dry. May be used on surfaces such as formica, stainless steel, porcelain, paint, and plastic.

Precautions

CAUTION. For external use only. Keep out of reach of children. Contents under pressure. **DO NOT** use near flame or excessive heat. **DO NOT** puncture or incinerate container. Exposure to temperatures above 122°F may cause bursting.
